Bidding will be conducted through open competitive bidding under the Revised Implementing Rules and Regulations (RIRR) of RA 9184, otherwise known as the Government Procurement Reform Act, using non-discretionary "pass/fail" criteria as specified in the IRR-A of RA 9184. The prospective bidder must have an experience of having completed a single contract that is similar to the contract to be bid and whose value must be at least fifty percent (50%) of the Approved Budget for the Contract. Only Bids from Bidders who pass the eligibility check will be opened. The bidder with the Lowest Calculated Bid (LCB) shall advance to the post-qualification stage in order to finally determine responsiveness of the bid to technical and financial requirements of the Project. 5. Bid Evaluation :August 21, 2019,BAC Office, 9:00a.m-10:00a.m
6. Post Qualification :August 22, 2019,BAC Office, 9:00a.m-10:00a.m
7. Approval of Resolution/ Issuance of Notice of Award :August 23, 2019,BAC Office, 9:00a.m-10:00a.m

The Bids of interested bidders must be submitted to the BAC Secretariat on or before the scheduled Opening of Bids. Late bids shall not be accepted. Bids will be opened in the presence of the Bidders/ representatives who choose to attend at the scheduled Opening of Bids. Any effort by a bidder to influence the Procuring Entity in its decision in respect of bid evaluation, bid comparison or contract award will result in the rejection of the Bidder's bid.
