Bidding will be conducted through open competitive bidding under the Revised Implementing Rules and Regulations (RIRR) of RA 9184, otherwise known as the Government Procurement Reform Act, using non-discretionary "pass/fail" criteria as specified in the IRR-A of RA 9184. The prospective bidder must have an experience of having completed a single contract that is similar to the contract to be bid and whose value must be at least fifty percent (50%) of the Approved Budget for the Contract. Only Bids from Bidders who pass the eligibility check will be opened. The bidder with the Lowest Calculated Bid (LCB) shall advance to the post-qualification stage in order to finally determine responsiveness of the bid to technical and financial requirements of the Project.
